EASY APPLICATION INSTRUCTIONS

APPLY USING A ROTARY SPREADER
RECOMMENDED SPREADER SETTING IS 60%.

APPLY AS A PROTECTIVE 18" WIDE STRIP directly at the edge of the bed or drip line of the targeted plants. Also apply a light dusting throughout the bed or plot being protected. For overly aggressive rabbit activity, increase to a 24" wide strip and apply heavier. After application, lightly water weekly.

FOR LAWN AND GARDEN AREAS OF 11,000 OR LESS SQUARE FEET, we recommend covering the entire area.

REAPPLY Use every 30 to 45 days depending on weather. May have to reapply after heavy rainfalls.

ALL SEASON USE! Each application of Rabbit Scram Professional should last 30 days including normal rainfall or irrigation.

DO NOT USE on food or feed crops. Do not apply directly to water.

FOR OUTDOOR USE ONLY.
